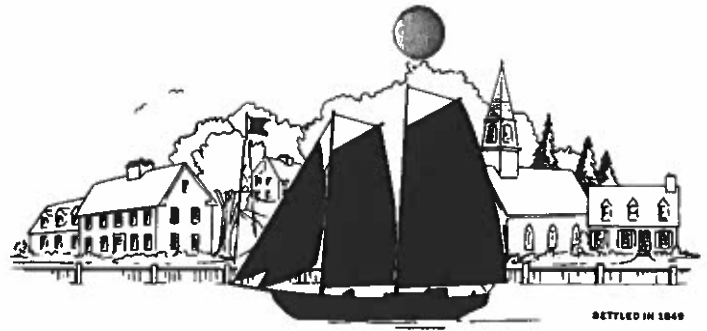

VILLAGE OF NORTHPORT ORDINANCE NUMBER 78

AN ORDINANCE TO REGULATE AND CONTROL CONSTRUCTION, OPERATION, USE, AND OR MAINTENANCE WITHIN THE VILLAGE RIGHT-OF-WAY WITHIN THE LIMITS OF THE VILLAGE OF NORTHPORT.

THE VILLAGE OF NORTHPORT ORDAINS:

SECTION 1: No person, firm, or corporation shall construct, operate, or maintain within the village right-of-ways without first obtaining required permits from the village clerk or designated representative.

SECTION 2: Permits will be required for but not limited to: placement of driveways, driveway culverts, sewer openings, storm sewers, sidewalks, irrigation systems, and water service.

SECTION 3: Fees for such permits will be a mandatory \$10.00 or such other amount as subsequently determined by resolution from time to time by the Northport Village Council.

SECTION 4: A bond of \$100.00 will be required as deemed necessary by the Zoning Administrator. Authorization for the refund of the \$100.00 bond will take place upon final inspection and determination by the Street Administrator as to whether or not the project complies with the permit; including site restoration.

SECTION 5: All conditions listed on application shall be complied with. The actual application is subject to change as subsequently determined by resolution from time to time by the Northport Village Council.

SECTION 6: Any person, firm, or corporation which violates any of the provisions of this ordinance or regulations, promulgated pursuant thereto, shall be deemed guilty of a misdemeanor and shall be punished by imprisonment for not

more than ninety (90) days, or a fine of not more than Five Hundred Dollars (500.00), or both.

SECTION 7: The provisions of this ordinance are hereby declared to be severable and if any clause, sentence, word, section or provision is declared void or unenforceable for any reason by any court of competent jurisdiction, it shall not affect any portion of the ordinance other than said part or portion thereof.

SECTION 8: This ordinance shall take effect on July 23, 1987. All ordinances or parts of ordinances in conflict with any of the provisions of this ordinance are hereby repealed.
